**Summary:** The Central Iowa Food Security Plan Navigation Pilot Program was developed out of community wide convening and release of the Central Iowa Food Security Plan. The goal of this program is to enhance food security by connecting individuals and families to resources and services through a Community Navigator representative at various locations where food is provided to community members in need. The program will also collect data to analyze and identify ways to improve the services provided to the community members in Central Iowa.

The program is seeking a community navigator position to serve at 2 host site organizations in Johnston and Altoona.

Contract Period: Current – June 30, 2026, with possible contract extensions through March 2027.

- 1. Welcome community members as they arrive at the food assistance location: Build relationships and trust with community members.
- 2. **Resource Referral and Application Assistance:** Connect community members with community resources beyond the service they are receiving.
- 3. **Expand community connections and relationships:** Advance the program's success by having a community presence by identifying opportunities and events in the community.
- 4. **Data Management:** Maintain accurate records of interactions and service referrals for the community members. Compile data for reporting purposes and program evaluation.
- 5. **Team Collaboration:** Ensure efficient and coordinated service delivery at host organizations and collaboration with fellow navigators to meet the goals of the project.
- 6. **Cultural Competence:** Demonstrate cultural sensitivity and respect for diversity in serving community members from various backgrounds and experiences.

#### **Contractor Requirements:**

- Experience working in social services, community outreach, or related fields.
- Ability to work independently and collaboratively in a team environment.
- Knowledge of local community resources and social service agencies.
- Proficiency in basic computer skills (e.g., data entry, email, and internet research).
- High school diploma or equivalent.
